What is Education?

Webster's 1828 dictionary defines it as The bringing up, as of a child, instruction; formation of manners. education comprehends all that series of instruction and discipline which is intended to enlighten the understanding, correct the temper, and form the manners and habits of youth, and fit them for usefulness in their future stations. To give children a good education in manners, arts and science, is important; to give them a religious education is indispensable; and an immense responsibility rests on parents and guardians who neglect these duties.

Education is Inherently Religious No thought or idea is neutral (Col. 1:15-18) Education is multi-generational (Ps. 78:1-7) Education is teaching and learning • "educate" - to instill into the mind principles of arts, science, morals, religion and behavior – pouring in "educe" – bring or draw out; to extract – drawing out The Scriptures support the same ingredients ■ In the <u>Home</u> – Eph. 6:4 – *nurture and admonish* ■ In the <u>Church</u> – Mt. 28:20 – *learner and to teach* **Biblical Education is** *discipleship*

It is hence plain that Hebrew parents were required not only to teach their children orally, but also to impart to them the arts of reading and writing. There is reason to believe, that the ability to read and write was an accomplishment, more generally possessed by the Hebrews, than by any other people of antiquity... from a survey of the matter, the conclusion seems warranted, that the education of the Hebrew people, conducted mainly though, not wholly, under the domestic roof, was nevertheless a national education, and worthy of the imitation of other nations... The result was that the nation reached a high point of literary attainment and distinction...

- ^{2nd} Cor. 3:17-18; Ro. 12:1-2 Sanctification Reflection – looking as in a glass (the notebook) Creativity – renewing of the mind (the essay) ■ Application – proving the will of God (outlet to use) Greek (mind) dianoia (deep thought) has the prefix dia which means channel, or canal **Reflection**, expression and practical application is a river-bed – 1st Peter 1:13 - prepare your minds for action
 - The Spirit of God uses a canal to produce *action;* tearing down strongholds (Ps. 39:3; 2nd Cor. 10:5)


The scholastics were medieval schoolmen who tended to be very intellectual but not very practical. In their thinking, reason and revelation are separate ideas and ought not to be reconciled. Scholasticism made a distinction between the theoretical and the practical; faith is one thing, but man's reason is another. In sharp contrast to the scholastics, Peter Ramus, and subsequently, William Ames, believed that knowledge should be practical; that God gave man the capacity to reason from revelation; that learning and doing walk together.... Peter Ramus felt that Aristotle, the Greek philosophy, was inconsistent..."

The Latin word curriculum... means a running, a racecourse, a chariot (currere)... A curriculum is thus the chariot, racecourse, or vehicle whereby a culture expresses its religious faith and standards. The... liberal arts curriculum, 'liberal' from the Latin liber, free... is a course in the arts of freedom... A liberal arts curriculum is thus a practical answer to the question, What is liberty? And, How does a man prepare himself to be a free man?"



Jurisdiction; the key to restoring a Nation's Education System

- Every religion has a corresponding form of government and education philosophy to support its continuity, thus...
 - It is best to center education in the home
 - Parental choice is critical to maintain to promote in any national system
 - Local community control for public schools balances both unity and diversity

It has been demonstrated that...

- The more centralized, quality decreases
- The more we focus on externals and equipment, the less we do teaching/learning The more government oversees education at the state and federal level, cost increases The more education is institutionalized, the less the curriculum equips students for life The more a "one size fits all" approach is taken, schools violate values of parents

The Scriptures guide us...

- Home education until 7... then tutors until a child turns 20 (college school of prophets)
- The parents decided when a child was mature enough for independent educators
- Civil government required parents to see that their child was educated or "neglected"
- Only role of direct civil government at the national level was the military
- Today, the question is, to whom do the children belong? (State or the parent/God)

What should parents do?

- Martin Luther; "I advise no one to place his child where the Scriptures do not reign paramount. Every institution that does not unceasingly pursue the study of God's Word becomes corrupt."
- Parents need to remain vigilant as to what is taught
 Most importantly, are the teachers and school equally yoked with the parent's faith/philosophy?
- Are parents willing to grow in a Biblical worldview?
 Education has become the main vehicle through which our children's minds have been corrupted
